

## 2024 Trade Ally Renewal Bonus

## Bonus structure

Tier 1: Renewal documentation received by Dec 31, 2023	\$250 bonus paid to Trade Ally
Tier 2: Renewal documentation received by Jan 31, 2024	\$100 bonus paid to Trade Ally
Tier 3: Renewal documentation received by Feb 29, 2024	\$50 bonus paid to Trade Ally (Third tier not eligible for BIDP)

## Eligibility
